**LA DEFENSORA DE LOS HABITANTES DE LA REPÚBLICA**

Con fundamento en los artículos 1 y 2 de la Ley de la Defensoría de los Habitantes de la República de Costa Rica, N° 7319, publicada en La Gaceta N° 237 del 10 de diciembre de 1992 y de conformidad con lo que establecen los artículos 7 incisos ch), d), h) e i), 9 incisos a), d), i) 10 y 11 del Reglamento de la Defensoría de los Habitantes, Decreto Ejecutivo No. 22266-J del 15 de junio de 1993:

**CONSIDERANDO**

- I. Que la Fundación Friedrich-Ebert-Stiftung (FES), la Alianza Global de Instituciones Nacionales de Derechos Humanos (GANHRI por su siglas en inglés) y la Oficina del Alto Comisionado de Derechos Humanos (OHCHR por su siglas en inglés) realizan anualmente actividades de capacitación para el personal de las Instituciones Nacionales de Derechos Humanos (INDH) de las diferentes regiones en todo el mundo. Lo anterior, con el propósito de fortalecer capacidades y conocimientos sobre el funcionamiento de los diferentes mecanismos de protección de los derechos humanos.
- II. Que del 1 al 5 de mayo del año en curso, será desarrollada la capacitación "*Training Course for National Human Rights Institutions on International Human Rights Mechanisms*", en la Ciudad de Ginebra, Suiza.
- III. Que para la Defensoría de los Habitantes, resulta de especial interés, el acceso a capacitaciones de alto nivel para sus funcionarias y funcionarios para promover su interacción con el sistema internacional de derechos humanos.
- IV. Que la FES y OHCHR cubre los gastos relacionados con la actividad, incluyendo boleto aéreo, seguro médico, alojamiento y un estipendio diario para la alimentación. Con presupuesto propio de la Defensoría se cubre la cena del día de llegada y posibles gastos menores.
- V. - VI. Que en virtud del interés que reviste esta actividad de capacitación para la Defensoría, la Defensora de los Habitantes, Montserrat Solano Carboni, autoriza la participación de la licenciada Tatiana Mora Rodríguez para atender el curso a celebrarse del 1 al 5 de mayo de 2017.


